Finger prints (rolled type) may be taken at any local police station, Regular Army Post, or Army Recruiting Station in your locality.
- 4. Submit resignation to your employer upon receipt of this letter, thereby giving 5 weeks' notice. Make plans to leave for Station Hospital, Advanced Flying School on or about date given in the second paragraph. Lawrenceville, Ill.
 - 5. Kindly advise as to whether you plan to travel by privately owned automobile or by train. If by train, your transportation will be sent with your orders. If by auto, you will be reimbursed after arrival at station. \$4.00 per diem is authorized to all nurses for meals and tips. Baggage up to 150 pounds may be checked on ticket. Each nurse upon reporting for duty will wear her civilian white uniforms, caps and shoes when on hospital duty until regulation Army uniforms are provided.
